**Qns.**- What is the issue of EWS who has been called for Document Verification and Medical but no post allocated to them?

Ans:- Priority for posts have been obtained by the candidates while filling up applications form, those EWS candidates who were qualifying in UR cut-off were called against UR posts but some of the candidates were not getting higher preference of post at the time of allotment against UR vacancies were shifted to EWS category and allotted higher preference of posts as per his/her choice. Such 59 EWS candidates on UR merit were considered against EWS quota. Hence, last 59 candidates initially called for DV against EWS quota could not get any allotment due to non-availability of EWS posts.

Those 59 candidates may be adjusted in case of replacement panel sought by Division/Units and rejection of pending candidates.
